2026 STANDING ORDER TRANSFERRING PROTECTIVE CUSTODY

In the interest of providing solutions to aid those suffering from mental health difficulties given hospital administrative formalities it is,

ORDERED, ADJUDGED and DECREED that the Order for Protective Custody rendered in connection with the Application for Court-Ordered Temporary Mental Health Services and Motion for Protective Custody attached hereto is hereby transferred to the state-licensed inpatient mental health facility, located in Montgomery County, Harris County, or Fort Bend County as designated on Page Two attached hereto where the Patient shall be held pending final hearing on an Application for Temporary Mental Health Services currently scheduled as indicated in the attached Order for Protective Custody or until discharged by the facility, whichever comes first. The receiving facility is ordered to produce the Patient for said hearing as scheduled in the attached Order of Protective Custody. The facility designated on page two shall fulfill all terms of the attached Order of Protective Custody.


It is further **ORDERED** that Mental Health Deputies are authorized to take charge of the Patient and to transport Patient to the designated inpatient mental health facility.
